

# CEO Response: Public Sector Spending Review

June 2025



## 1. Introduction

The Chancellor's Public Sector Spending Review, announced on 11 June 2025, has significant implications for UK policing, particularly concerning Labour's pre-election commitments. While the review outlines substantial investments in areas like health, housing, and infrastructure, it falls short in providing the necessary funding to meet Labour's policing objectives. The Chancellor hangs the governments hopes on driving productivity and efficiencies through Al. Whilst this captures headlines, it is unlikely to yield meaningful results for anyone other than the large consulting firms. As Forensic Analytics has demonstrated, productivity and efficiency can, when working with ambitious police forces, deliver results through existing technologies.

# 2. Chancellor Rachel Reeves' Spending Review: Policing Implications

The Spending Review allocates a £2.1 billion increase in police funding from 2026 to 2029, equating to a real-terms rise of just 1.7% per year. This modest increase is projected to result in a £1.2 billion shortfall, potentially forcing police forces to reduce headcount. The National Police Chiefs' Council (NPCC) warns that this funding gap undermines Labour's pledge to recruit 13,000 neighbourhood police officers, a key election promise. The Police Federation and Police Superintendents' Association criticised the spending review as a failure to prioritise public safety after years of austerity.

## 3. Labour's Pre-Election Policing Commitments

Prior to the 2024 general election, Labour outlined several key objectives for policing:

- Recruitment of 13,000 additional neighbourhood police officers and PCSOs, funded through a Police Efficiency and Collaboration Programme.
- **Crackdown on antisocial behaviour**, introducing tough new penalties for offenders and a new network of youth hubs.
- **Combatting knife crime**, with measures such as mandatory plans to prevent reoffending for young people caught in possession of a knife.
- **Tackling violence against women and girls**, including specialist domestic abuse workers in 999 control rooms and specialist rape investigation units in every force.
- Addressing youth crime, through the introduction of a new offence of criminal exploitation of children and a 10-year Young Futures programme.

### 4. Comparison and Analysis

The Chancellor's Spending Review provides a modest increase in police funding, which may not be sufficient to meet Labour's ambitious policing objectives. The projected funding gap raises concerns about the feasibility of fulfilling commitments such as recruiting 13,000 additional officers and implementing comprehensive crime prevention measures.

### 5. Conclusion

The Chancellor's Spending Review, whilst pivoting from years of austerity, falls short in addressing the funding needs of UK policing. Without additional investment, Labour's pre-election commitments may be challenging to achieve, potentially impacting public safety and trust in law enforcement.
